Dear Sectional Women's Directors and Team Captains:

RE: 2020 USTA National Women's Intersectional Team Event – Hard Court Championships

Enclosed is your invitation and packet of information for the 2020 USTA National Women's Intersectional Team Event. This prestigious event will be held at the Phoenix Tennis Center in Phoenix, Arizona. All information for this year's event can be found on our website at <https://www.ustaphoenix.com/womens-intersectionals>.

Due to the very fluid situation with Covid-19, please make sure you're travel plans are flexible and/or refundable. Also, at this time we will not be able to host the social events and Gala Dinner as we have in the past. We hope to be able to host these events and if we are able to, tickets to the Gala Dinner will be available for purchase at a later date. We have reduced the entry fee this year to reflect this.

The date for this year's event is November 9-15, 2020, each team plays a max of four consecutive days beginning on the following dates: play will begin for the 55s, 65s and on Monday the 9th, for the 75s, 80s and 85s on Tuesday the 10th, and for the 35s and 45s on Thursday the 13th.

Sponsors of the event are The United States Tennis Association, The National Women's Tennis Organization and USTA Southwest.

Play this year will be on hard courts. Remember that play in this Team Championship will count as a tournament played for USTA National ranking purposes. As in recent years, players will receive points for their wins for national ranking purposes as outlined in the point chart for Intersectionals. For the 55s, 65s and 85s; Sunday, November 8, 2020, for 75s and 80s; Monday, November 9, 2020, and for 35s and 45s; Wednesday, November 11, 2020. All Captain's meetings are tentatively scheduled to be held at 6:00 p.m. on those dates and will be held in one of the conference rooms at the Embassy Suites.

All of us at USTA Southwest are looking forward to meeting all of the players from your section and all of the other participating sections for a week of great competition and camaraderie.

Procedures for 2020 Women's Intersectional Team Championships

(changes for 2020 marked in red)

All USTA Sections are eligible to field a team in each age division as follows: 35s, 45s, 55s, 65s, 75s, 80s and 85s. The 85s division is new for 2020!

These events will count for USTA national ranking purposes. Players shall earn ranking points in national ranking tournaments based on a points per round ranking system. This information is published on the USTA website.

The 5x table is used for the National Women's Intersectional Team Event, which has 3 or 4 matches per position. A player who plays at more than one position can end up with points in between the lowest and highest position she plays.

TEAM SELECTION

Each USTA Section shall have the sole responsibility for selecting team members by whatever criteria it deems appropriate. **Players must be members of the USTA through the Section for which they play.** Sections are strongly encouraged to have written selection procedures.

TEAM FORMATS

35s, 45s, 55s, 65s: 3 singles and 2 doubles – the minimum number of players is 4 and the maximum is 7.

75s: 2 singles and 2 doubles – the minimum number of players is 4 and the maximum is 7.

80s: 1 singles and 2 doubles – the minimum number of players is 4 and the maximum is 7.

85s: 1 singles and 1 doubles – the minimum number of players is 2 and the maximum is 5.

Players may compete in both singles and doubles. A player may play in two different age divisions if eligible but may play in only one age divisions in singles and only one age division in doubles on the same day.

Furthermore, a player may compete in two different age divisions if eligible, under the following team listing restraints:

- For the 35s, 45s, 55s, 65s age divisions, the top 3 singles players cannot be double rostered.
- For the 75s age division, the top 2 singles players cannot be double rostered.
- For the 80s and 85s age divisions, the top singles player cannot be double rostered.



Procedures for 2020 Women's Intersectional Team Championships (cont.)

TEAM CAPTAINS

The sections must designate captains before the competition begins. Captains must attend the on-site Captains' Meetings. The captain may be a playing captain or a non-playing captain. An individual may captain more than one age group.

COMPETITION FORMAT

The competition in each age category may be a compass draw, modified compass draw, or a round robin. The tournament committee will determine which format to use so that each team will play a minimum of three team matches.

A team member will not be required to play more than the number of matches per day allowed for her age division according to the regulations for USTA Adult and Senior National Championships. In general, this means a team will play only one (1) team match per day. The referee can alter this if he/she determines that the event cannot be completed on time because of weather delays or other unforeseen circumstances.

SCORING

One point for each court win. The team with the majority of the points shall be the winner of the team match. All matches will be played even if a team winner has been established (time, weather, and courts permitting). A winner or "champion" team will be determined in each age category. **If inclement weather prohibits a final or 3rd place playoff match from completing (i.e. a team winning the majority of the points), then the teams will be named "Co-Champions" or "Co-3rd Place".**

75s and 85s Age Division Tiebreak:

In the event of a 2-2 tie in the 75s or a 1-1 tie in the 85s, the tiebreak order will be as such:

- Least number of sets lost
- Least number of games lost
- If still tied, the captains will vote on one of two tiebreak methods during the captain meeting.
 1. The #1 doubles court will be worth two points giving the winning team a 3-2 win for the 75s or a 2-1 win for the 85s. OR
 2. Each team will select any two players to play a doubles, "Super Match Tiebreaker". First to 10 points, win by 2.

LINE UP AND DRAW

A roster shall be submitted by the section for each team in each age category represented. Players must be listed in order of strength as singles players. All team members shall be listed on the singles roster even if they plan to play only doubles (a doubles roster is not required). Final changes to team rosters and resolution of order of strength questions shall be made at the captains' meeting prior to the making of the draw.

Seeding: A seeding committee will determine preliminary seeding prior to the captains' meeting. All current player information (significant wins, losses, rankings) must be submitted to the tournament committee with the player information sheets in order to formulate preliminary seeding. Any questions concerning seeding will be resolved prior to the making of the draw. One team in four will be seeded, however, in an age category where there are 12 or more teams, four seeds will be allowed.



Procedures for 2020 Women's Intersectional Team Championships (cont.)

Substitutions: A substitution in the daily singles line-up may be made at the discretion of the captain. A substitute must be placed in accordance with the team roster's order of strength.

Doubles Teams:

Formation of doubles teams will be at the discretion of the team captain. This will be discussed in more detail at the initial Captains' Meetings.

Daily Line-ups:

The time frame for turning in the daily singles line-ups shall be determined by the referee and announced at the captains' meeting. Doubles line-ups do not have to be turned in until 15 minutes after the last singles match has been completed for that particular team match.
